OFFICIAL NOTICE OF SCHOOL GOVERNING BODY (SGB) BY-ELECTION: PARENT REPRESENTATIVES

In accordance with the **South African Schools Act, 1996 (Act 84 of 1996)** and the **Provincial Regulations for the Election of School Governing Bodies**, notice is hereby given of a **by-election** to fill vacancies in the **Parent Component of the School Governing Body (SGB)**.

Reason for the By-Election

Two (2) vacancies have arisen due to the affected parents' learners **having completed Grade 12 at the end of the 2025 academic year**, which resulted in the automatic termination of their membership on the School Governing Body, as prescribed by law.

Purpose

The purpose of this by-election is to:

- Nominate, and
- Elect **two (2) parents of learners currently enrolled at the school** to serve on the School Governing Body for the remainder of the current SGB term.

Election Details

Date: 21 February, 2026

Time: 10h00 - 12h00

Venue: John Orr School Hall

Eligibility (as per Regulations)

Only **parents or legal guardians of learners currently registered at the school** may

- Be nominated, and
- Vote in the election.

Parents must be **present at the meeting** to nominate, be nominated, and vote.

- Each parent is entitled to **one vote per vacancy**.

Nomination Procedure

Official nomination forms will be made available at the school at least seven (7) days prior to the election date, in line with Provincial SGB Election Regulations.

- Nomination forms will **also be available on the day of the election**, and nominations may be made **from the floor**, subject to acceptance by the nominee in person.
- All nominees must meet eligibility requirements and must **formally accept their nomination**.


Election Procedure

- If the number of nominees exceeds the number of vacancies, the election will be conducted by **secret ballot**, as prescribed by the Regulations.
- The election process will be overseen by the **appointed Electoral Officer** to ensure fairness, transparency, and compliance.

All parents are **strongly encouraged to attend**, as parental representation on the School Governing Body is a statutory requirement and is vital for effective school governance and the best interests of learners.
